

## **Biography of Panel Speakers**

## Mr. Allan Ngari

Allan Ngari is the Director of Advocacy, Africa Division at Human Rights Watch.

He has extensive experience and expertise on Africa's human rights landscape and the advocacy opportunities and challenges now and in the coming years. Previously at the Centre for the Study of Violence and Reconciliation, whereas the Advocacy Programme Manager since June 2022, he facilitated a knowledge agenda on transitional justice and human rights, and provided strategic leadership to secure multi-stakeholder cooperation, partnerships, and funding for the Center's work with the African Union, regional economic communities and mechanisms, as well as with AU member states, civil society organizations, victim groups and associations, and women and youth groups. Prior to that, Allan was the Dakar, Senegal-based West Africa Regional Coordinator for the ENACT Project at the Institute for Security Studies, where he implemented a multi-Euro EU and German Foreign Office funded project with ECOWAS Commission and ECOWAS Member States on knowledge management and response to organized crime in West Africa.

Through his work, over 6 years, with the Institute for Security Studies in South Africa, Allan researched issues and coordinated projects to advance the fight against impunity for serious crimes and human rights violations in Africa. Among many other roles at the ISS, he coordinated the work plans of the Global Counter-Terrorism Forum's East Africa and West Africa Working Groups, which involved policy research, advocacy, and technical assistance to Central, East, Horn, and West African countries to develop and implement processes relating to radicalization, violence, and violent extremism. Before the ISS, Allan worked at the Institute for Justice and Reconciliation, Cape Town -South Africa, running projects on the Great Lakes (Burundi, DRC, Rwanda, and Uganda) and Greater Horn, and then led the Kenya and International Justice desks on transitional justice and reconciliation, gender justice, electoral reform, and civic education, as well as reparations for victims of human rights abuse, and the impact of mass trauma.

A prolific writer and public analyst, Allan has published in English and French- dozens of reports, policy briefs, working papers, media articles and opinions. He holds a law degree from the University of Nairobi and a Master of Law degree from Stellenbosch University and speaks Kikuyu (his native Kenyan language), Swahili, English, French and basic Portuguese.

Also, she led projects dedicated to enhancing Mental Health services under the umbrella of peacebuilding and projects aimed to improve community resilience and self-reliance. Sulaima has 21 years of experience working on Psychosocial Support Projects for children and communities affected by war and conflict or living in underprivileged situations in Sudan, working with different UN agencies, INGOs and NGOs. Currently, Sulaima is finalizing her PHD Project, which focuses on establishing a Curriculum of Comprehensive Protection and Psychosocial Support Program for Professionals who works with children with disability. Sulaima is also an activist on Child protection, Gender-Based Violence, Human rights, development initiatives and Using Art as a medium of social change. She is a member of the INSAF Campaign of Transitional Justice. Sulaima is married, a mother of four children and lives with her family in Omdurman.
